WE CONTINUED TO EDUCATE THE PUBLIC ABOUT WHAT REPRODUCTIVE HEALTH DECISIONS AT THE SCOTUS AND/OR FEDERAL LEVEL MEANT FOR NEW MEXICANS AND PROVIDED COMMUNICATIONS SUPPORT FOR REPRODUCTIVE HEALTHCARE PARTNERS. IN ENVIRONMENTAL JUSTICE WE PARTNERED WITH OTHER ENVIRONMENTAL ORGANIZATIONS TO CONTINUE EDUCATION ON THE HARMFUL EFFECTS AND THE ROLE THE OIL AND GAS INDUSTRY HAS IN NEW MEXICO POLITICS AS WELL AS EDUCATIONAL VIDEOS RELATED TO VARIOUS CLEAN ENERGY SOLUTIONS.
