WE CONTINUED TO EDUCATE THE PUBLIC ABOUT HOW REPRODUCTIVE HEALTH DECISIONS IN OTHER STATES AFFECT NEW MEXICANS AND PROVIDED COMMUNICATIONS SUPPORT FOR REPRODUCTIVE HEALTHCARE PARTNERS.
