We also support underserved communities in the Philippines, including those who are impacted by natural disasters and conflicts. We regularly conduct health, relief, and solidarity missions in these communities.

1. MEMS is a program that seeks to put survivor voices in the lead of building a community-based movement to end human trafficking.

Through MEMS, NAFCON works with community partners to provide a safe and healing space for survivors to share their stories, dismantle shame, and reclaim their dignity. The main organizational expense of the program is the payment for three contractors – Executive Director, Program Director, and Legal Associate. MEMS' annual summit was held in Los Angeles for the first time in May 2018, bringing over 300 trafficking survivors and community advocates. MEMS also developed and consolidated a paralegal team of 7 trafficking survivors and assisted 17 survivors to apply for T-visas. Throughout the year, 251 participants received Know Your Rights Training. Through its Executive Director, MEMS is also able to speak at various events and activities around the country for education, alliance building, and campaign development. Advocates and community partners also donated in-kind goods and services such as legal services and use of room/meeting spaces and resources in the amount of \$15,100.

Through health and solidarity missions, we provide concrete support to grassroots communities and NGO partners in the Philippines who are impacted by disasters, including typhoons and armed conflicts. We adopted a rural community impacted by coal stockpiling, wherein we

We began raising funds for the costs of the mission such as medical supplies and collecting program fees from participants for accommodation and food for the mission. We also continued to collect relief donations for Marawi conflict victims and disaster victims.

3. Immigrant Rights Campaign:

Through partnership with the Filipino Community Center, NAFCON conducted various trainings on immigrant rights, education and advocacy and campaign development nationally during this fiscal year. The trainings focused on emerging issues affecting the immigrant Filipino community and incorporated our partnerships with community organizations, legal groups, media outlets, church leaders, and research institutions to respond to important service and education needs across the country. We engaged over 300 participants in the workshops and trainings to build the capacity of community groups and organizations in over 10 U.S. cities across the country to respond to these urgent issues in our community through strategic planning support, assessments and evaluations, and resource sharing with strong partnerships now in place to sustain these efforts over the longer term. The main expense for this project continues to be hiring a consultant on a contractual basis to develop program strategies, conduct the trainings, oversee and implement the work, and evaluate and share best practices.
