The mission of Girls Rising is to empower underserved girls to recognize their value and pursue higher goals through a community of women mentors.

28 Girls Rising serves an average of 70 at-risk girls annually, all from vulnerable socio-economic backgrounds. Each girl is partnered with a long term mentor to serve as a consistent, positive role model. The program also hosts and finances a minimum of 8-10 educational events each year focused on exposing the girls to new experiences. The Program Manager recruits and trains mentors, provides support to the matches, collects data, organizes events. The Executive Director builds community connections and raises funds for the program (100% supported by donations), and provides management.
