In FY19 we pushed back against proposed projects to expand the use of fossil fuels, continued a successful program to train young climate leaders of color to run for elected office, provided organizing fellowships to community college students, coordinated and facilitated trainings for youth climate activists and continued to fiscally sponsor and mentor youth climate leaders of color.
