In FY21 we pushed back against proposed projects to expand the use of fossil fuels, coordinated and facilitated trainings for youth climate activists and continued to fiscally sponsor and mentor youth climate leaders, especially those from BIPOC and other marginalized identities. We also held a national convening for youth activists to build skills on organizing and campaigning for climate justice.
