INVESTIGATING: AMCHA Initiative released a groundbreaking report examining antisemitic activity in 2019, which documented a more than 300% increase in campus activity intended to undermine and discredit the global acceptance of anti-Zionism as a form of antisemitism, which was strongly correlated with an increase in the harassment of Jewish students. In addition, AMCHA Initiatives survey on Survey of Antisemitic Activity and Trends on American Campuses was a featured mini-report in the Tel Aviv University Kantor Centers report on Antisemitism Worldwide 2020: General Analysis. DOCUMENTING: As the only publicly-accessible, user-friendly database of antisemitic activity on more than 400 campuses nationwide, AMCHAs website is an invaluable resource for university stakeholders, allied organizations, state and federal legislators and scholars. As a result of the large increase in the number of online recordings of lectures and events due to the COVID-19 pandemic, over 380 recordings were reviewed for antisemitic activity during this period, and AMCHAs Antisemitism Incident Tracker documented hundreds of incidents of antisemitic activity. EDUCATING: During this period, AMCHAs data, studies and efforts were cited in more than 300 articles in outlets that included The New York Times, The Wall Street Journal, The Los Angeles Times, The Washington Times, The Hill, Inside Higher Ed, The Chronicle of Higher Education, TIME Magazine, The Forward, Haaretz, Jewish Telegraph Agency, Jewish Journal and many more. AMCHAs data, studies and efforts regarding San Francisco State University also played a crucial role in the Lawfare Projects lawsuit on behalf of two SFSU students, that resulted in a successful settlement. In addition, AMCHAs director discussed the problem of campus antisemitism and AMCHAs efforts to combat it on radio shows and podcasts, and presented AMCHAs work in several webinars. During this reporting period, AMCHA sent out 25 bulletins to 10,000 supporters and issued 15 press releases to hundreds of media outlets. COMBATING: During this period, AMCHA coordinated dozens of initiatives involving an at-will coalition of over 135 religious, civil rights, education and advocacy organizations and thousands of grassroots activists, most of the efforts focused on exposing and educating about the antisemitic nature of Critical Ethnic Studies and opposing legislative that would facilitate the widespread adoption of antisemitic Ethnic Studies curricula in public and charter schools in California.
