THROUGH RESEARCH AND COMMENTARY, TLC SEEKS TO ENCOURAGE BIPARTISANSHIP AMONG ELECTED OFFICIALS AND INFORM THE PUBLIC ON THE NEGATIVE IMPACT OF PARTISANSHIP IN OUR GOVERNMENT.
