FEDERAL LEGISLATIVE ADVOCACY: IJF ENGAGED IN SCENARIO PLANNING TO REFINE POST-ELECTION STRATEGIES, OUTLINING LEGISLATIVE ADVOCACY PRIORITIES THAT THE ORGANIZATION COULD MOVE FORWARD BASED ON VARIOUS ELECTION RESULT SCENARIOS. 2020 ELECTIONS PROJECT: THE NILC IMMIGRANT JUSTICE FUND (IJF) CONTINUED ITS WORK ON A GROUNDBREAKING PROJECT FOCUSED ON THE 2020 PRESIDENTIAL ELECTIONS CYCLE, PROVIDING TESTED, PRO-IMMIGRANT MESSAGES TO PERSUADABLE VOTERS IN KEY BATTLEGROUND STATES, AS WELL AS TO POLITICAL CANDIDATES AND ELECTED OFFICIALS. USING THIS FOUNDATIONAL MESSAGING WORK, IJF ANALYZED PRIMARY CANDIDATES' IMMIGRATION POLICY PLATFORMS, PROVIDED FEEDBACK ON THEIR IMMIGRATION POLICY PLATFORMS, AND DEMONSTRATED TO ELECTED OFFICIALS THROUGHOUT ELECTION DEBATES THAT IMMIGRANTS ARE VALUABLE POLITICAL CONSTITUENCY, ESSENTIAL TO THE FUTURE STABILITY AND VITALITY OF THE COUNTRY.
