	RESEARCH: WITH THE 2024 PRESIDENTIAL ELECTION CYCLE UNDERWAY, THE NILC IMMIGRANT JUSTICE FUND (IJF) BEGAN AN OPPOSITION RESEARCH PROJECT TO GENERATE UNIQUE, IMPACTFUL CONTENT THAT HIGHLIGHTS THE EXTREME POSITIONS OF CANDIDATES PURSUING THE REPUBLICAN NOMINATION FOR PRESIDENT. IJF ANALYZED THE VARIOUS POLICY POSITIONS AND BUILT A LANDING PAGE ON IJF'S WEBSITE SO CANDIDATES, PARTNERS, AND OTHER STAKEHOLDERS CAN ACCESS THE INFORMATION. MESSAGING AND POLLING: IJF INITIATED QUALITATIVE RESEARCH ON THE MINDSETS OF THE 2024 ELECTORATE.
