THE ON-SITE STAFFING MODEL AT EACH OF ARC'S TWO HOUSING SITES IN LOS ANGELES ENSURES SUPPORTIVE SERVICE DELIVERY SUCH AS LIFE SKILLS DEVELOPMENT TO PROMOTE SELF-SUFFICIENCY AND RESILIENCE AMONG MEMBERS. LIFE COACHES ENSURE THAT ALL RESIDENTS ARE EITHER IN SCHOOL OR WORKING PART-TIME AND SAVING A PORTION OF THEIR INCOME.
