WORKFORCE AND EDUCATION ARC OFFERS A VARIETY OF CAREER PREPARATION WORKSHOPS DESIGNED TO HELP INDIVIDUALS SUCCEED IN THE JOB MARKET. THESE WORKSHOPS INCLUDE CAREER READINESS, A 20-HOUR PROGRAM FOCUSING ON THE FUNDAMENTALS OF EMPLOYMENT ACQUISITION AND RETENTION, DIGITAL LITERACY, A 12-HOUR WORKSHOP TEACHING ESSENTIAL MOBILE AND TECH SKILLS, AND FINANCIAL LITERACY, AN 18-HOUR COURSE COVERING BASIC CHECKING AND SAVINGS PRACTICES.IN ADDITION TO WORKSHOPS, ARC PROVIDES INTERNSHIP OPPORTUNITIES AND SCHOLARSHIP SUPPORT FOR ADULTS AND TRANSITIONAL-AGE MEMBERS. ONE OF OUR KEY VOCATIONAL TRAINING INITIATIVES IS THE LOS ANGELES APPRENTICESHIP READINESS PROGRAM, AN 11-WEEK PROGRAM CREATED THROUGH A PARTNERSHIP BETWEEN THE LOS ANGELES UNIFIED SCHOOL DISTRICT (LAUSD) AND THE LA/OC BUILDING TRADES. THIS SUCCESSFUL PROGRAM HAS RECENTLY EXPANDED TO SAN BERNARDINO. PARTICIPANTS IN THE PROGRAM RECEIVE STIPENDS DURING COHORT TRAINING BEFORE BEING PLACED DIRECTLY INTO UNION APPRENTICESHIPS.
