IN 2023, EQUAL JUSTICE UNDER LAW MADE GREAT STRIDES ADVANCING ITS MISSION FOR GREATER EQUALITY IN THE JUSTICE SYSTEM. THE ORGANIZATION WON A PERMANENT INJUNCTION AGAINST THE USE OF MONEY BAIL IN SACRAMENTO AFTER MORE THAN SEVEN YEARS OF LITIGATION, SECURING DUE PROCESS AND EQUAL PROTECTION RIGHTS FOR RESIDENTS OF SACRAMENTO. EQUAL JUSTICE UNDER LAW ALSO MADE IMPORTANT PROGRESS IN ITS FIGHT AGAINST WEALTH-BASED DISCRIMINATION IN MONTANA AND TEXAS, WHERE IT IS LEADING CASES AGAINST MANDATORY AND NON-WAIVABLE PRETRIAL SUPERVISION FEES. IT ALSO GOT CLOSER TO ENDING WEALTH-BASED LICENSE SUSPENSIONS IN MISSOURI, AS THE STATE ENACTED LEGISLATION DESIGNED TO END PUNITIVE AND DISCRIMINATORY PRACTICES. THROUGH ALL OF THIS WORK, EQUAL JUSTICE UNDER LAW IS HELPING CREATE A JUSTICE SYSTEM THAT IS MORE EQUAL.
