IN 2025, EQUAL JUSTICE UNDER LAW MADE GREAT STRIDES ADVANCING ITS MISSION FOR GREATER EQUALITY IN THE JUSTICE SYSTEM. THE ORGANIZATION MADE IMPORTANT PROGRESS IN ITS FIGHT AGAINST WEALTH-BASED DISCRIMINATION IN MONTANA, WHERE ITS LEADING CASE AGAINST MANDATORY AND NON-WAIVABLE PRETRIAL SUPERVISION FEES IS SCHEDULED TO GO TO TRIAL IN 2026. IT ALSO GOT CLOSER TO ENDING WEALTH-BASED LICENSE SUSPENSIONS IN MISSOURI, WORKING TOWARDS GRANTING PERMANENT RELIEF FOR INDIGENT CLIENTS WITH REMAINING LICENSE SUSPENSIONS AFTER THE STATE ENACTED LEGISLATION TO HALT FUTURE SUSPENSIONS.
