Accountability - In 2020, 350 Seattle staff helped coordinate the Stop the Money Pipeline coalition, which kicked off in January with actions at Chase branches in Seattle and DC and grew to more than 150 organizations nationally. In April STMP ran a campaign to get former Exxon CEO Lee Raymond removed from the Chase Board of Directors. By the end of the year, Chase had announced that he was leaving. We also supported tech workers organizing for climate justice across the tech industry, including showing up in support of Amazon warehouse workers fighting for safer pandemic working conditions and paid time off to vote, as well as partnering with grassroots organizations in warehouse communities fighting for environmental justice. As part of the latter effort, we supported tech workers in filing a shareholder resolution to investigate concerns of environmental racism in logistics operations and bringing attention during the shareholder meeting to the harm that truck polution causes families.

Movement Support - Pivoting our work to account for all the changes that came with the pandemic, we trained 1,397 people in how to engage with direct action, including sessions such as Keep Yourself Safe at a Protest, How Movements Can and Do Win, and De-Escalation and Peacekeeping. We also ran a 4-part Racial Justice is Climate Justice learning series, attended by 347 people, and deepened our community roots by seeding 43 neighborhoods mutual aid pods. Our art team worked with 200 volunteers to create banners and window paint for car actions, to engage with outdoor, socially distant art builds, to create virtual banners, art how-to videos and Zoom song teach-ins. Finally, our social media also grew to over 16,000 across Facebook, Twitter and Instagram.

Solutions - We partnered with Sunrise Seattle to activate 70 volunteers in support of the Solidarity Budget - a community-driven vision with six key demands for Seattle's 2021 City Budget that confronts the overlapping crises of the systemic racism, economic injustice, and climate chaos. For the first year ever, Seattle didnt grow its police budget but instead cut the budget by 18% and re-invested in housing, healthy environments, COVID-19 relief, and community solutions. We also helped launch the Tax Amazon campaign in early 2020, getting signatures for a ballot initiative to fund affordable housing and Green new Deal Solutions. Tax Amazon came together with a broader coalition to pass JumpStart Seattle-a tax on big business that raises \$212 million/year for emergency COVID-19 relief, affordable housing, and Green New Deal solutions like transitioning low-income homes off fossil fuels. During this years legislative session, we also led 165 volunteers from 298 districts across teh state to make nearly 6,000 legislative contacts in support of better climate justice policies. Finally, we also launched the 350 WA Network, bringing together 12 local 350.org groups around WA state, to give us more leverage to act in the years to come.
