UNLESS OTHERWISE PROVIDED IN THE BYLAWS OR REQUIRED BY LAW, IF A MORE ADVANTAGEOUS TRACTION OR ARRANGEMENT IS NOT REASONABLY FEASIBLE UNDER CIRCUMSTANCES NOT RESULTING IN A CONFLICT OF INTEREST, THEN BEFORE CONSUMMATING THE TRANSACTION OR ARRANGEMENT, OR ANY PART THEREOF, THE BOARD MUST IN GOOD FAITH AND WITH KNOWLEDGE OF THE INTERESTED PERSONS FINANCIAL INTEREST, ESTABLISH BY A MAJORITY VOTE OF THE DISINTERESTED DIRECTORS WHETHER THE PROPOSED TRANSACTION OR ARRANGEMENT: (I) IS IN THE ORGANIZATION'S BEST INTEREST, (II) IS FOR THE ORGANIZATION'S OWN BENEFIT, AND (III) WOULD BE FAIR AND REASONABLE TO THE ORGANIZATION AT THE TIME THE ORGANIZATION ENTERED IN THE TRANSACTION OR ARRANGEMENT. 3. AN INTEREST PERSON MAY MAKE A PRESENTATION OAT THE BOARD OR COMMITTEE MEETING, BUT AFTER THE PRESENTATION, THAT PERSON SHALL LEAVE THE MEETING DURING THE DISCUSSION OF, AND THE VOTE APPROVING OR DISAPPROVING THE TRANSACTION OR ARRANGEMENT INVOLVING THE POTENTIAL CONFLICT OF INTEREST, UNLESS OTHERWISE PROVIDED IN THE BYLAWS. 4. THE EXECUTIVE DIRECTOR SHALL, IF APPROPRIATE, APPOINT A DISINTERESTED PERSON OR COMMITTEE TO INVESTIGATE ALTERNATIVES TO THE PROPOSED TRANSACTION OR ARRANGEMENT. IF THE EXECUTIVE DIRECTOR, BOARD OR COMMITTEE HAS REASONABLE CAUSE TO BELIEVE THAT A PERSON HAS FAILED TO DISCLOSE ACTUAL OR POTENTIAL CONFLICTS OF INTEREST, IT SHALL INFORM THE PERSON OF THE BASIS FOR SUCH BELIEF AND AFFORD THE PERSON AN OPPORTUNITY TO EXPLAIN THE ALLEGED FAILURE TO DISCLOSE. IF, AFTER HEARING THE PERSON'S RESPONSE AND AFTER CONDUCTING FURTHER INVESTIGATION AS WARRANTED BY THE CIRCUMSTANCES, THE BOARD OR COMMITTEE DETERMINES THE PERSON HAS FAILED TO DISCLOSE AN ACTUAL OR POTENTIAL CONFLICT OF INTEREST, THE BOARD SHALL TAKE APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION.

THE DOCUMENTATION OF THE BOARD INCLUDES THE TERMS OF TRANSACTION AND THE DATE OF APPROVAL, THE MEMBERS WHO WERE PRESENT DURING THE DEBATE AND VOTE ON THE TRACTION, A DESCRIPTION OF THE COMPARABLE DATA AND HOW IT WAS OBTAIN, AND DOCUMENTATION OF THE BASIS FOR THE DETERMINATION.
