The organization litigated two lawsuits in federal court against Harvard University and the University of North Carolina at Chapel Hill, alleging that these universities are violating the Fourteenth Amendment and Title VI of the Civil Rights Act of 1964 by engaging in racial discrimination in their admissions processes. The organization also commenced to litigate a lawsuit in Federal court against the University of Texas-Austin concerning claims of racial discrimination in the admissions process.

The organization made a controlled grant to pay legal fees and expenses in litigation challenging the California ballot initiative known as Proposition 16, which ballot initiative sought to repeal a state constitutional provision prohibiting discrimination in public education.
