The organization successfully won two lawsuits at the Supreme Court against Harvard University and the University of North Carolina at Chapel Hill, alleging that these universities are violating the Fourteenth Amendment and Title VI of the Civil Rights Act of 1964 by engaging in racial discrimination in their admissions processes. The organization also continued to litigate a lawsuit in Federal court against the University of Texas-Austin concerning claims of racial discrimination in the admissions process.
