EDUCATION, TRAINING, OUTREACH AND PUBLISHING: WEBINARS - GIJN PRODUCED 64 WEBINARS DURING 2020 WITH TOPICS RANGING FROM THE COVID-19 PANDEMIC AND JOURNALIST SAFETY TO ONLINE RESEARCH TECHNIQUES AND DISINFORMATION.NEWSLETTERS - GIJN PRODUCED AND DISTRIBUTED E-NEWSLETTERS OF THE LATEST TOOLS, EVENTS, AND NEWS IN INVESTIGATIVE JOURNALISM. THE NEWSLETTERS APPEARED WEEKLY IN SIX DIFFERENT LANGUAGES AND REACHED AN AUDIENCE OF NEARLY 20,000.WORKSHOPS AND TRAINING - GIJN RAN ONLINE WORKSHOPS ON SUCH TOPICS AS INTERNET SEARCH SKILLS AND MEDIA BUSINESS MANAGEMENT.
