THE NEWSLETTERS APPEARED IN NINE LANGUAGES AND REACHED AN AUDIENCE OF NEARLY 27,000.WORKSHOPS, TRAINING AND MENTORSHIP - GIJN RAN ONLINE WORKSHOPS ON SUCH TOPICS AS INTERNET SEARCH SKILLS AND MEDIA BUSINESS MANAGEMENT. AND, FOR THE FIRST TIME, GIJN PRODUCED TARGETED TRANSLATIONS IN SEVERAL INDIGENOUS LANGUAGES: GUARANI, QUECHUA, AND YUCATEC MAYAN. ANNUAL CONFERENCE: GLOBAL INVESTIGATIVE JOURNALISM CONFERENCE - DUE TO THE GLOBAL SPREAD OF COVID-19, GIJN DECIDED TO MOVE ITS GLOBAL INVESTIGATIVE JOURNALISM CONFERENCE (GIJC21) ONLINE TO PROTECT ITS STAFF, SPEAKERS AND ATTENDEES AGAINST THE ENDURING THREAT OF THE PANDEMIC. GIJN'S FIRST ALL-VIRTUAL GIJC21 BROUGHT TOGETHER 1,668 ATTENDEES FROM A RECORD 144 COUNTRIES. ATTENDEES JOINED 77 SESSIONS OVER FIVE DAYS ON A VARIETY OF TOPICS, AS WELL AS TARGETED NETWORKING SESSIONS. THE CONFERENCE ATTRACTED AN EXTRAORDINARY 109 MILLION TWITTER IMPRESSIONS, REACHING AN ESTIMATE OF 32 MILLION PEOPLE WORLDWIDE. GIJN DID NOT HOLD THE ANNUAL CONFERENCE IN 2022.
