ON AVERAGE, THE WEBINARS SAW 91 PARTICIPANTS.NEWSLETTERS - GIJN PRODUCED AND DISTRIBUTED E-NEWSLETTERS OF THE LATEST TOOLS, EVENTS, AND NEWS IN INVESTIGATIVE JOURNALISM.
