EDUCATION, TRAINING, OUTREACH, AND PUBLISHING:WEBINARS - GIJN PRODUCED 22 WEBINARS IN ELEVEN LANGUAGES IN 2024 WITH TOPICS RANGING FROM CLIMATE CHANGE JOURNALISM TO INVESTIGATING ELECTIONS AND THREATS FROM AI AUDIO DEEPPAKES. ON AVERAGE, THE WEBINARS SAW 162 PARTICIPANTS. THE MOST ATTENDED WEBINAR, FOLLOW THE MONEY--INVESTIGATING SHELL COMPANIES, SAW 552 ATTENDEES FROM 97 COUNTRIES.NEWSLETTERS - GIJN PRODUCED AND DISTRIBUTED E-NEWSLETTERS OF THE LATEST TOOLS, EVENTS, AND NEWS IN INVESTIGATIVE JOURNALISM. THE NEWSLETTERS APPEARED IN SEVEN LANGUAGES AND REACHED AN AUDIENCE OF OVER 40,000 PEOPLE.WORKSHOPS, TRAINING, AND MENTORSHIP - GIJN RAN ONLINE AND IN-PERSON WORKSHOPS ON TOPICS SUCH AS INTRODUCTION TO INVESTIGATIVE JOURNALISM, DEEP INTERNET RESEARCH, AND REPORTING ON WAR.RESOURCE CENTER - GIJN'S FREE ONLINE RESOURCE CENTRE HOLDS MORE THAN 2,000 ITEMS IN 14 LANGUAGES - AN IMPRESSIVE DIGITAL LIBRARY OF RESOURCES FOR PUBLIC-INTEREST INVESTIGATORS ON MATERIALS RELATED TO INVESTIGATIVE AND DATA JOURNALISM, USED BY JOURNALISTS IN 140 COUNTRIES EACH DAY. ITS LAST CONFERENCE, HELD IN SEPTEMBER 2023 IN GOTHENBURG, SWEDEN, ATTRACTED OVER 2,100 JOURNALISTS FROM 130 COUNTRIES. ATTENDEES JOINED 200 SESSIONS OVER 4 DAYS ON A VARIETY OF TOPICS, AS WELL AS TARGETED NETWORKING SESSIONS.
