ROUNDTABLES: CODE hosts open data roundtables and workshops to bring together government agencies and the organizations that use their data. In 2022 CODE held a major roundtable with the Bezos Earth Fund to explore the potential for an environmental justice data collaborative in the U.S. CODE followed the roundtable with an in-person workshop for key potential members of that collaborative. CODE also held a roundtable with the organization Measures for Justice on improving data for fair policing and published a report from a 2021 roundtable on the social determinants of health.

4b (Code:) (Expenses \$ 152,453 including grants of \$ 0) (Revenue \$ 56,146)

RESOURCES: CODE develops print and online resources for the community of data users both in the U.S. and internationally. In 2022 CODE continued its technical leadership of Open SDG an open source platform for reporting on the UN Sustainable Development Goals. In the U.S. CODE co-led the development of a toolkit to support stakeholder engagement by federal agencies for their open data programs and published a resource and data hub with about 700 resources on environmental justice. CODE supported the UN Statistics Division in its plans to redesign the UN Data portal. Internationally CODE also began work on an online tool the Climate DART to help countries use data for climate adaptation and resilience.

RESEARCH: In 2022 CODE wrote a major research paper published by PARIS21 an organization within the OECD on the benefits of an ecosystem approach in managing data related to climate change. CODE also partnered with the IBM Center for the Business of Government to publish three research reports on different aspects of the use of data to improve racial equity in healthcare housing and workforce opportunity. In addition CODE conducted a landscape analysis for the Bezos Earth Fund to identify opportunities to work with historically black colleges and universities HBCUs on environmental and climate data across the U.S.
