CODE completed a project with FEMA that gathered public input on FEMA's flood risk information and risk communication programs and presented FEMA with final recommendations. In other federal work CODE held a large-scale Roundtable to gather input on the CDC's national strategy for vector-borne diseases and collaborated with the U.S. Department of Commerce on a Roundtable on using AI to make government data more usable. CODE also held a Roundtable with the population health management company ZeOmega on new data-driven approaches to meeting health-related social needs
