OUR WORK BRINGS TOGETHER REPUBLICANS AND DEMOCRATS, BUSINESSES LARGE AND SMALL, PEOPLE OF FAITH, AND ALLIES FROM ALL WALKS OF LIFE TO MAKE THE CASE FOR COMPREHENSIVE NON-DISCRIMINATION PROTECTIONS THAT ENSURE EVERYONE IS TREATED FAIRLY AND EQUALLY.
