OUR WORK BRINGS TOGETHER REPUBLICANS AND DEMOCRATS, BUSINESSES LARGE AND SMALL, PEOPLE OF FAITH, AND ALLIES FROM ALL WALKS OF LIFE TO MAKE THE CASE FOR COMPREHENSIVE NON-DISCRIMINATION PROTECTIONS THAT ENSURE EVERYONE IS TREATED FAIRLY AND EQUALLY. WITH THE ULTIMATE GOAL OF SECURING FEDERAL STATUTORY PROTECTIONS FOR LGBTQ AMERICANS, FREEDOM FOR ALL AMERICANS WORKS AT THE FEDERAL, STATE, AND LOCAL LEVEL TO ADVANCE MEASURES AND LAWS PROTECTING FROM DISCRIMINATION ON THE BASIS OF SEXUAL ORIENTATION AND GENDER IDENTITY AND EXPRESSION - WITHOUT ALLOWING OVERLY BROAD AND HARMFUL RELIGIOUS EXEMPTIONS THAT WILL ENCOURAGE EMPLOYERS, BUSINESS OWNERS OR OTHERS TO CHOOSE TO DISREGARD THOSE PROTECTIONS.
