A. FINANCIAL INTEREST EXISTS WITH RESPECT TO ANY PERSON WHO HAS, DIRECTLY OR INDIRECTLY, THROUGH BUSINESS, INVESTMENT, OR FAMILY ANY OF THE FOLLOWING INTERESTS: A. AN OWNERSHIP OR INVESTMENT INTEREST IN ANY ENTITY WITH WHICH THE ELECTRIC VEHICLE ASSOCIATION HAS A TRANSACTION OR ARRANGEMENT, B. A COMPENSATION AGREEMENT WITH THE ELECTRIC VEHICLE ASSOCIATION OR WITH ANY ENTITY OR INDIVIDUAL WITH WHICH THE ELECTRIC VEHICLE ASSOCIATION HAS A TRANSACTION OR ARRAGEMENT, OR C. A POTENTIAL OWNERSHIP OR INVESTMENT INTEREST IN, OR COMPENSATION AGREEMENT WITH, ANY ENTITY OR INDIVIDUAL WITH WHICH THE ELECTRIC VEHICLE ASSOCIATION IS NEGOTIATING A TRANSACTION OR ARRAGEMENT, D. FOR PURPOSES OF POLICY, COMPENSATION INCLUDES DIRECT AND INDIRECT REMUNERATION AS WELL AS GIFTS OR FAVORS THAT ARE NOT INSUBSTANTIAL. 2. DETERMINING WHETHER A CONFLICT OF INTEREST EXISTS - ELECTRIC VEHICLE ASSOCIATION WILL GENERALLY ADDRESS CONFLICTS OF INTEREST IN ONE OF THE WAYS TO AVOID POTENTIAL LEGAL LIABILITY. AN INDIVIDUAL WITH A SERIOUS POTENTIAL CONFLICT MUST TAKE NO PART IN THE ELECTRIC VEHICLE ASSOCIATION ISSUE THAT RAISES THE POTENTIAL CONFLICT. FOR LESS SERIOUS POTENTIAL CONFLICTS, THERE MUST BE DISCLOSURE TO ELECTRIC VEHICLE ASSOCIATION AND AVOIDANCE OF PARTICIPATING IN DEBATE AND VOTING ON THE ISSUE FOR WHICH THERE IS A POTENTIAL CONFLICT. FINALLY, FOR MINOR POTENTIAL CONFLICTS, THERE SIMPLY MUST BE FULL DISCLOSURE TO ELECTRIC VEHICLE ASSOCIATION. IT IS ELECTRIC VEHICLE ASSOCIATION'S PREROGATIVE, NOT THAT OF THE INDIVIDUAL, TO MAKE SUCH DETERMINATIONA REGARDING CONFLICTS. ELECTRIC VEHICLE ASSOCIATION BELIEVES THAT IT IS PRUDENT TO ERR ON THE CONSERVATIVE SIDE AND AVOID EVEN THE APPEARANCE OF CONFLICTS OF INTEREST. ELECTRIC VEHICLE ASSOCIATION HAS IDENTIFIED A NUMBER OF GENERAL CATEGORIES OF ACTUAL OR POTENTIAL CONFLICTS OF INTEREST. THEY INCLUDE BUT ARE NOT LIMITED TO: (1) OFFICERS AND DIRECTORS OF ELECTRIC VEHICLE ASSOCIATION ACTING AS OFFICIAL OR APPOINTED REPRESENTATIVES OF ELECTRIC VEHICLE ASSOCIATION, AND MEMBERS AND STAFF ACTING ON BEHALF OF ELECTRIC VEHICLE ASSOCIATION, SHOULD DISCLOSE ANY SITUATION IN WHICH THEY, OR A MEMBER OF THEIR IMMEDIATE FAMILY, HAVE FINANCIAL, CONTRACTUAL, OR OTHER INTERESTS THAT COULD INTERFERE WITH THE ACTING IN AN UNBIASED MANNER ON BEHALF OF THE ELECTRIC VEHICLE ASSOCIATION. IN SUCH INSTANCES, THE INDIVIDUAL MAY BE ASKED TO RECUSE THEMSELVES FROM THEIR POSITION OR WORK WITH ELECTRIC VEHICLE ASSOCIATION. (2) OFFICERS AND DIRECTORS OF ELECTRIC VEHICLE ASSOCIATION SHOULD EXERCISE CAUTION BEFORE ENTERING INTO FINANCIAL OR LEGAL ARRAGEMENTS THAT COULD PREJUDICE OR BIAS THEIR CONDUCT OR VIEWS IN ISSUES RELATED TO ELECTRIC VEHICLE ASSOCIATION. IF SUCH ARRANGEMENTS EXIST OR ARE PERCEIVED TO EXIST, THAT INDIVIDUAL SHOULD DISCLOSE THESE ARRANGEMENTS. EXAMPLES OF RELEVANT SITUATIONS WOULD INCLUDE PAID RELATIONSHIPS OR FINANCIAL INTERESTS WITH VENDORS DOING, OR SEEKING TO DO, BUSINESS WITH ELECTRIC VEHICLE ASSOCIATION. (3) INDIVIDUALS OR MEMBERS OF COMMITTEES PREPARING OFFICIAL STATEMENTS FOR ELECTRIC VEHICLE ASSOCIATION SHOULD DISCLOSE FINANCIAL RELATIONSHIPS OR LEGAL OBLIGATIONS THAT INTERFERE, OR COULD INTERFERE, WITH THE TASK. THE PRESIDENT OF THE BOARD IS AUTHORIZED TO INVESTIGATE, OR DELEGATE SUCH AUTHORITY, WHEN A POTENTIAL CONFLICT MAY EXIST THAT IS NOT SELF-IDENTIFIED BY A PERSON OR HAS BEEN INDEPENDENTLY FORWARDED TO THE BOARD FOR FURTHER REVIEW. THIS POLICY IS DIRECTED PRINCIPALLY AT OFFICERS AND DIRECTORS OF ELECTRIC VEHICLE ASSOCIATION, MEMBERS OF THE BOARD OF DIRECTORS, CHAPTER AND COMMITTEE MEMBERS AND GROUPS WORKING ON BEHALF OF ELECTRIC VEHICLE ASSOCIATION, MEMBERS WHO SPEAK ON BEHALF OF ELECTRIC VEHICLE ASSOCIATION, AND ALL STAFF OF ELECTRIC VEHICLE ASSOCIATION. 3. VIOLATIONS OF THE CONFLICTS OF INTEREST POLICY A. IF THE BOARD OF COMMITTEE HAS REASONABLE CAUSE TO BELIEVE A PERSON HAS FAILED TO DISCLOSE ACTUAL OR POSSIBLE CONFLICTS OF INTEREST, IT SHALL INFORM THE PERSON OF THE BASIS FOR SUCH BELIEF AND AFFORD THE PERSON AN OPPORTUNITY TO EXPLAIN THE ALLEGED FAILURE TO DISCLOSE. B. IF, AFTER HEARING THE PERSON'S RESPONSE AND AFTER MAKING FURTHER INVESTIGATION AS WARRANTED BY THE CIRCUMSTANCES, THE BOARD OR COMMITTEE DETERMINES THE PERSON HAS FAILED TO DISCLOSE AN ACTUAL OR POSSIBLE CONFLICT OF INTEREST, IT SHALL TAKE APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION.
