PEACE OVER VIOLENCE(POV) PROVIDED SERVICES TO OVER 20,500 INDIVIDUALS REGARDING SEXUAL ASSAULT DOMESTIC VIOLENCE TEEN DATING VIOLENCE SEXUAL HARASSMENT AND/OR STALKING IN THE 22-23 FISCAL YEAR. THE SERVICES INCLUDED EMERGENCY RESPONSE LEGAL ADVOCACY CASE MANAGEMENT COUNSELING HOTLINES COMMUNITY OUTREACH AND TRAINING BOTH VIRTUALLY AND IN-PERSON IN THE L. A.
