LCLAA REPRESENTS THE INTEREST OF MORE THAN 2 MILLION LATINO WORKERS IN THE AMERICAN FEDERATION OF LABOR-CONGRESS OF INDUSTRIAL ORGANIZATIONS (AFL-CIO), THE CHANGE TO WIN FEDERATION, INDEPENDENT UNIONS AND ALL ITS MEMBERSHIP.
