RATHER THAN GATHER IN HOTEL LOBBIES, BALLROOMS, AND MEETING ROOMS, THE COVID-19 PANDEMIC MEANT OVER 2,200 PARTICIPANTS JOINED THE CONFERENCE FROM THEIR LIVING ROOMS. FOUR DAYS OF VIRTUAL PROGRAMMING KEPT ALIVE THE ENDURING SPIRIT OF CREATING CHANGE: DAYLONG INSTITUTES, WORKSHOPS, CAUCUSES, THE ANNUAL INTERFAITH SERVICE - EVEN GAME NIGHT AND THE ANNUAL HOUSE BALL!
