WE OPERATE OUT OF OUR HARM REDUCTION DROP-IN CENTER AND THROUGH A POP UP AT THE DOWNTOWN DAY SERVICES CENTER. IN 2022, WE OFFERED CLOTHING, FOOD, HOUSING NAVIGATION, RE-ENTRY SUPPORT FOR LGBTQ INDIVIDUALS RETURNING FROM INCARCERATION, REFERRALS AND MORE TO OVER 2,400 CLIENTS.
