OUT-OF-SCHOOL TIME (OST) PROGRAMMING AT CHILD FIRST AUTHORITY IS A RESEARCH-INFORMED STRATEGY THAT EXTENDS LEARNING BEYOND THE SCHOOL DAY, PROVIDING SAFE AND ENRICHING ENVIRONMENTS WHERE STUDENTS GROW ACADEMICALLY, SOCIALLY, AND EMOTIONALLY. OST PROGRAMS REINFORCE CLASSROOM LEARNING WHILE OFFERING OPPORTUNITIES FOR EXPLORATION, SKILL-BUILDING, AND YOUTH DEVELOPMENT.AT CHILD FIRST AUTHORITY, OST PROGRAMS SERVE AS A STRUCTURED PLATFORM FOR COORDINATING ACADEMIC SUPPORT, ENRICHMENT, AND STUDENT ENGAGEMENT IN ALIGNMENT WITH SCHOOL-DAY GOALS. ADDITIONAL SITE LEADERSHIP POSITIONS INCLUDE AN ACADEMIC COORDINATOR WHO IS RESPONSIBLE FOR IMPLEMENTING AND SUPPORTING ALL COMPONENT OF THE ACADEMIC PORTION OF THE PROGRAM, ALONG WITH A PARENT INVESTMENT COORDINATOR WHO CULTIVATES RELATIONSHIPS WITH PARENTS AND STRENGTHENS FAMILY ENGAGEMENT.CORE COMPONENTS INCLUDE ACADEMIC ENRICHMENT, YOUTH DEVELOPMENT AND LEADERSHIP, ARTS AND CULTURAL EXPERIENCES, HEALTH AND WELLNESS, AND FAMILY ENGAGEMENT. AT CHILD FIRST AUTHORITY, COMMUNITY SCHOOLS OPERATE AS THE "OPERATING SYSTEM" FOR COORDINATING PARTNERSHIPS, ALIGNING RESOURCES, AND ADDRESSING BARRIERS TO LEARNING SUCH AS CHRONIC ABSENTEEISM, UNMET HEALTH NEEDS, AND FAMILY INSTABILITY.
