Human Rights: We acted fiscal sponsor for groups dedicated to promoting indigenous rights, environmental rights, labor rights, and human rights, we played a crucial role in advancing these causes. Additionally, we ran another cohort of students in the popular education program, the Lucy Parsons Popular Human Rights School.

Racial Justice Through fiscal sponsorship, weve supported racial justice groups affiliated with Black Lives Matter, bail funds, and prison abolition or reform organizations, aiding in the liberation of political prisoners. Additionally, through sponsorship of bail funds, we provided assistance to individuals through legal aid, advocacy, and community support initiatives aimed at addressing systemic racism and promoting racial equity.

Movement Building: Through fiscal sponsorship services, weve supported over 100 groups committed to the progressive movement, enabling them to access resources and expand their influence in advocating for social and economic justice initiatives. We provide comprehensive administrative support, including donation processing, accounting services, and access to payroll and group health benefits. Additionally, we supported philanthropic relationships of our projects and ensure tracking of interim and final reporting on grants received, providing both financial and programmatic oversight for numerous grants.

Foreign Policy: We facilitate efforts to change U.S. relations with countries in Latin America and the Middle East, while advocating for just U.S. immigration policies. Weve hosted webinars addressing various foreign policy and immigration topics, disseminated advocacy alerts, and maintained a strong social media presence to amplify voices for foreign policy reform. Furthermore, weve organized delegations to Latin America, providing participants with firsthand experiences of successful initiatives, participatory democracy projects, and human rights advocacy efforts. These experiences have contributed to freeing political prisoners, exposing prison conditions, and shedding light on the impact of the exportation of U.S. mass incarceration model across the globe. This can fall under the broad spectrum of anti-war work.
