IN MAY 2020, JOTF ESTABLISHED THE COMMUNITY BAIL FUND FOR BALTIMORE CITY TO PROVIDE BAIL PAYMENTS FOR ELIGIBLE RESIDENTS REPRESENTED BY THE MARYLAND OFFICE OF THE PUBLIC DEFENDER. JOTF IS REIMBURSED IF THE BAILRECIPIENT ATTENDS THE SCHEDULED COURT HEARING AND THE MONEY IS APPLIED TO A FUTURE BAIL PAYMENT AS THE PROGRAM CONTINUES. MANAGEMENT DETERMINED THAT IT IS PROBABLE THAT SOME RECIPIENTS OF FUNDING UNDER THE PROGRAM WILLNOT ATTEND THEIR COURT HEARING, AND THE RELATED BAIL FUNDS WILL BE FORFEITED AT THAT TIME. THEREFORE, MANAGEMENT PROVIDED FOR AN ALLOWANCE FOR DOUBTFUL ACCOUNTS TO ESTIMATE THE AMOUNT OF FORFEITED FUNDS THAT WOULD OCCUR.SINCE ITS LAUNCH, JOTF HAS HOSTED NINE (9) COMMUNITY BAILOUT EVENTS AT THE BALTIMORE CENTRAL BOOKING AND INTAKE CENTER. AS OF DECEMBER 31, 2021, JOTF HAS SUCCESSFULLY POSTED \$280,501 IN BAIL FOR THIRTY-FOUR (34) INDIVIDUALS, INCLUDING EIGHT PERCENT (8%) OF THE CLIENTS WHO DID NOT APPEAR FOR COURT AND HAVE RECEIVED NEARLY \$210,000 BACK FROM THE COURTS DUE TO SUCCESSFUL COURT APPEARANCES.
