The CE-MHTTC focused it services on providing, disseminating, and implementing evidence-based practices and promising clinical practices that are effective in addressing mental illnesses and co-occurring substance and stimulant misuse. Services are provided free of charge. During the period, 92 events were held and 5,629 individuals participate.

Specifically, the CE-ATTC focused it services on providing, disseminating, and implementing evidence-based practices and promising clinical practices that are effective in addressing co-occurring substance and stimulant misuse. Services are provided free of charge. During this period, 102 T/TA events were held and 3,733 individuals participate.
