DURING THE FALL OF 2022, THE NPC ORGANIZED STUDY TEAMS, HELD STUDY GROUP MEETINGS, CONDUCTED STUDY ANALYSES, AND DEVELOPED PROPOSED REPORTS ON THESE TOPICS. IN DECEMBER 2022, THE NPC REVIEWED, FORMALLY APPROVED, TRANSMITTED TO THE SECRETARY AND PUBLISHED TWO RESULTING REPORTS ON (1) SHORT-TERM ACTIONS AND (2) TRANSITION STRATEGIES, ENTITLED:- PETROLEUM MARKET DEVELOPMENTS PROGRESS AND ACTIONS TO INCREASE SUPPLY AND IMPROVE RESILIENCE.- PRINCIPLES, AND OIL & GAS INDUSTRY INITIATIVES AND TECHNOLOGIES FOR PROGRESSING TO NET ZERO. HYDROGEN ENERGY STUDYBY LETTER DATED NOVEMBER 8, 2021, SECRETARY GRANHOLM FORMALLY REQUESTED THE NPC TO UNDERTAKE "A STUDY ON THE DEPLOYMENT OF LOW AND ZERO CARBON HYDROGEN ENERGY AT SCALE THROUGH THE ENTIRE VALUE CHAIN." DURING 2022, THE NPC ORGANIZED STUDY TEAMS, HELD STUDY GROUP MEETINGS, CONDUCTED STUDY ANALYSES, COMMISSIONED ACADEMIC MODELLING, AND DEVELOPED A REPORT OUTLINE ON THIS TOPIC. GREENHOUSE GAS (GHG) EMISSIONS STUDYBY LETTER DATED APRIL 22, 2022, SECRETARY GRANHOLM FORMALLY REQUESTED THE NPC TO UNDERTAKE "A STUDY THAT DEFINES PATHWAYS AND PRIORITIZES OPTIONS FOR GHG EMISSIONS REDUCTION ACROSS THE U.S. NATURAL GAS VALUE CHAIN." DURING THE REMAINDER OF 2022, THE NPC ORGANIZED STUDY TEAMS, HELD STUDY GROUP MEETINGS, CONDUCTED STUDY ANALYSES, AND DEVELOPED A REPORT OUTLINE ON THIS TOPIC. IT WAS PLANNED THAT THE STUDY GROUP MEETINGS AND ANALYSIS ACTIVITIES WOULD CONTINUE THROUGH 2023, WITH STUDY COMPLETION AND REPORT APPROVAL SET FOR SECOND QUARTER 2024.
