IN 2024, THE NATIONAL PETROLEUM COUNCIL'S (NPC) PRIMARY ACTIVITIES WERE ASSOCIATED WITH THE COMPLETION OF TWO NPC STUDIES CONDUCTED IN RESPONSE TO REQUESTS FROM THE SECRETARY OF ENERGY AND THE DEVELOPMENT OF POTENTIAL FUTURE STUDY TOPICS TO DISCUSS IN 2025 WITH THE INCOMING ADMINISTRATION.HYDROGEN ENERGY STUDYBY LETTER DATED NOVEMBER 8, 2021, SECRETARY GRANHOLM FORMALLY REQUESTED THE NPC TO UNDERTAKE "A STUDY ON THE DEPLOYMENT OF LOW AND ZERO CARBON HYDROGEN ENERGY AT SCALE THROUGH THE ENTIRE VALUE CHAIN." DURING 2022, THE NPC ORGANIZED STUDY TEAMS, HELD STUDY GROUP MEETINGS, CONDUCTED STUDY ANALYSES, AND DEVELOPED A REPORT OUTLINE ON THIS TOPIC. MOST OF THE STUDY GROUP MEETING AND ANALYSES ACTIVITIES WERE CONDUCTED DURING 2023, INVOLVING APPROXIMATELY 300 PARTICIPANTS. THE STUDY WAS COMPLETED, AND THE REPORT WAS APPROVED AT THE APRIL 23, 2024, NPC MEETING WITH PRINTING OF THE SUMMARY VOLUME AND POST-APPROVAL REPORT OUTREACH/COMMUNICATION ACTIVITIES BEING CONDUCTED THROUGHOUT THE REMAINDER OF 2024. PRINTING OF THE FULL-VOLUME REPORT WILL FOLLOW IN 2025. GREENHOUSE GAS (GHG) EMISSIONS STUDYBY LETTER DATED APRIL 22, 2022, SECRETARY GRANHOLM FORMALLY REQUESTED THE NPC TO UNDERTAKE "A STUDY THAT DEFINES PATHWAYS AND PRIORITIZES OPTIONS FOR GHG EMISSIONS REDUCTION ACROSS THE U.S. NATURAL GAS VALUE CHAIN." DURING THE REMAINDER OF 2022, THE NPC ORGANIZED STUDY TEAMS, HELD STUDY GROUP MEETINGS, CONDUCTED STUDY ANALYSES, AND DEVELOPED A REPORT OUTLINE ON THIS TOPIC. MOST OF THE STUDY GROUP MEETING AND ANALYSES ACTIVITIES WERE CONDUCTED DURING 2023, INVOLVING OVER 200 PARTICIPANTS. THE STUDY WAS COMPLETED IN THE FIRST QUARTER OF 2024 AND THE FINAL REPORT WAS APPROVED AT THE APRIL 23, 2024, NPC MEETING. PRINTING OF THE SUMMARY VOLUME AND POST-APPROVAL REPORT OUTREACH AND COMMUNICATION ACTIVITIES WERE CONDUCTED THROUGHOUT THE REMAINDER OF 2024. THE FULL REPORT VOLUMES WILL BE PRINTED IN 2025. POTENTIAL FUTURE STUDY TOPICSDURING THE APRIL 2024 NPC MEETING, DOE REQUESTED THE COUNCIL TO DEVELOP A LIST AND SUMMARY SCOPE OF POTENTIAL NEW STUDY TOPICS TO DISCUSS WITH THE NEXT ADMINISTRATION. A REPORT ON POTENTIAL STUDY TOPICS WAS COMPLETED IN LATE 2024.
