Part I, Line 2:	<p>Through our urban forestry program, American Forests helps develop and bring to life plans for planting and caring for city trees. Our approach to urban forestry is to focus on the socioeconomically disadvantaged neighborhoods that need trees the most. In our Innovation Lab, we empower the urban forestry field by developing climate change-informed forestry practices to optimize what trees to plant and protect for public health and climate change mitigation impact. This past year, we launched Tree Equity Score and the related Climate & Health Action Guide and Rhode Island species selection guide to help city leaders, urban forestry professionals, and residents look at neighborhood-level scores across a city or region and identify where resources should be focused in order to close any gap in tree cover between neighborhoods. Through our Tree Equity: Career Pathways Initiative we are closing the gap between urban forestry workforce needs and qualified workers. The focus of the initiative is training people from lower-income neighborhoods (where there are fewer jobs and trees) and placing individuals in urban forestry jobs. Our place-based work in select cities continues to deploy a change model derived from the Community Assessment and Goal-Setting Tool on Vibrant Cities Lab, which we continue to manage and grow. It includes facilitating partnerships, urban forestry planning guided by science, restoring and protecting urban forests, advocacy and funding, communication and adaptation. As part of this work in building local capacity, American Forests provides strategic grants to local organizations or agencies in the cities selected for long-term partnerships or projects. Outcomes associated with each grant vary and can include but not be limited to volunteer event coordination, land restoration, adaptable species selection, urban tree canopy analysis or inventory, workforce development, urban forestry master plan development, community engagement, or equipment purchase. For larger projects, a portion of funds are provided up-front with final payment delivered upon completion of the project and submission of final report. Grant decisions are based on many factors including strategic alignment, local capacity outcomes, and funding availability. All prospective grantees are required to submit proposals with a description of proposed work, budget details and timeline. Grantees agree to follow American Forests' communications, reporting and branding requirements, which include but are not limited to quality event and project implementation, before-and-after photographs, communications, community engagement, and progress reports.
