THEY PUBLISH AND COMMUNICATE THEIR FINDINGS THROUGH MEI'S COMMUNICATION CHANNELS AND THE NATIONAL AND INTERNATIONAL MEDIA. THEY REGULARLY BRIEF POLICYMAKERS, US AND FOREIGN DIPLOMATS, AND THE INTERNATIONAL BUSINESS COMMUNITY ON ISSUES IMPACTING THE MIDDLE EAST, AND HAVE ADVISED THE HIGHEST LEVELS OF GOVERNMENT INCLUDING CABINET SECRETARIES AND THE WHITE HOUSE.
