FOUNDED IN 1953, THE AFRICA-AMERICA INSTITUTE PROMOTES ENLIGHTENED ENGAGEMENT BETWEEN AFRICA AND AMERICA THROUGH EDUCATION, TRAINING AND DIALOGUE. AAI DESIGNS AND MANAGES PROGRAMS THAT ENABLE AFRICAN STUDENTS TO PURSUE ACADEMIC DEGREES AND NON-DEGREE PROFESSIONAL CERTIFICATES AT QUALITY TERTIARY (POST SECONDARY) INSTITUTIONS WITHIN AND OUTSIDE AFRICA. AAI PROGRAMS ALSO PROVIDE A PLATFORM FOR AFRICAN PERSPECTIVES TO INFORM U.S. POLICIES AND ATTITUDES TOWARD AFRICA THAT HAVE A BEARING ON AFRICAN HUMAN CAPACITY BUILDING. AAI’S CORE PURPOSE IS TO CONTRIBUTE TO THE REDUCTION OF POVERTY AND UNEMPLOYMENT, AND THE EXPANSION OF FREEDOM, IN AFRICA.
