ADVOCACY: VHA HAS AN ACTIVE LEGISLATIVE COMMITTEE THAT WORKS YEAR-ROUND TO DEVELOP POLICY FOR THE ORGANIZATION AND ADVANCE AFFORDABLE HOUSING AND HOMELESSNESS SOLUTIONS AT THE STATE AND FEDERAL LEVEL. EACH YEAR, VHA AND ITS MEMBERS AND PARTNERS HOLD A HOUSING DAY AT THE VIRGINIA GENERAL ASSEMBLY IN RICHMOND. THE EVENT GATHERS APPROXIMATELY 125 HOUSING ADVOCATES TO PARTICIPATE IN A TRAINING FOLLOWED BY MEETINGS WITH THEIR LEGISLATORS TO DISCUSS ITEMS ON OUR LEGISLATIVE AGENDA AND THE AFFORDABLE HOUSING AND HOMELESSNESS NEEDS IN THEIR COMMUNITIES. VHA ALSO COORDINATES HILL DAY VISITS IN PARTNERSHIP WITH THE NATIONAL LOW INCOME HOUSING COALITION AND NATIONAL ALLIANCE TO END HOMELESSNESS AND CONSTITUENTS FROM ACROSS THE COMMONWEALTH. VHA HOLDS TWO STATEWIDE PROFESSIONAL DEVELOPMENT AND NETWORKING EVENTS EACH YEAR. HOUSING VIRGINIA'S MOST VULNERABLE CONFERENCE IS THE COMMONWEALTH'S PREMIER PROFESSIONAL DEVELOPMENT OPPORTUNITY TO EXPLORE EMERGING STANDARDS AND BEST PRACTICES FOCUSED ON INTERVENTIONS AND SERVICES FOR THE MOST VULNERABLE POPULATIONS.
