DIRECT SERVICE DEPARTMENT ACCOMPLISHMENTS: PROVIDED COORDINATED HOMELESSNESS RESPONSE, HOUSING, AND OUTREACH SERVICES TO A SUBSTANTIAL NUMBER OF LOW-INCOME AND VULNERABLE WEST VIRGINIANS STATEWIDE. DURING THE CALENDAR YEAR, WVCEH SERVED 1,778 HOUSEHOLDS AND 2,527 INDIVIDUALS THROUGH HOUSING PROGRAMS, STREET OUTREACH, COORDINATED ENTRY, AND SPECIAL POPULATION PROGRAMS, ENSURING ACCESS TO ASSESSMENT, REFERRALS, AND HOUSING RESOURCES ACROSS THE CONTINUUM OF CARE. ACHIEVED STRONG HOUSING STABILITY OUTCOMES THROUGH PERMANENT SUPPORTIVE HOUSING AND RAPID RE-HOUSING PROGRAMS WHILE MAINTAINING FISCAL AND PROGRAMMATIC OVERSIGHT OF MULTIPLE FUNDING STREAMS.
