CanaVox facilitates reading groups for professionals, young adults, college students, and teenagers that discuss these issues in 43 states and 41 countries. CanaVox's website is www.canavox.com.

Academic Programs: These programs consist of seminars and one-on-one mentoring with Princeton University students and with promising students in high school, college, and graduate school at other institutions.
