IF DEEMED SIGNIFICANT, HE OR SHE IS TO CONSULT WITH THE PRESIDENT OF THE BOARD OF DIRECTORS TO DETERMINE A RESOLUTION. WAIVERS MAYBE GRANTED IF IN THE BEST INTEREST OF THE ORGANIZATION. A CONFLICT OF INTEREST REPORT IS PROVIDED TO THE BOARD OF DIRECTORS AT EACH REGULARLY SCHEDULED BOARD MEETING.
