THE EL COMMUNITY PROJECT CONDUCTS AN OPEN ENROLLMENT PROGRAM EACH YEAR. PARTICIPANTS LEARN TO APPLY THE PRACTICES AND PRINCIPLES OF EMERGENT LEARNING WITH OTHERS IN A COLLABORATIVE SETTING. THE PROGRAM BEGINS VIRTUALLY OVER FOUR MONTHS AND CULMINATES WITH A DAY AND HALF IN-PERSON MEETING. PARTICIPANTS RANGE FROM EARLY TO LATE-CAREER PROFESSIONALS IN FOUNDATIONS, NONPROFITS AND CONSULTING ORGANIZATIONS SEEKING TO MAKE A DIFFERENCE IN THEIR INTERNAL ORGANIZATIONAL LEARNING CULTURES, SOCIAL CHANGE INITIATIVES AND NETWORKS OR CONSULTING PRACTICES.
