Academy - During FY24-25, IBI delivered the Biochar Academy Kenya in collaboration with regional partners. The in-person program brought together more than 80 participants, including biochar producers, researchers, practitioners, and project developers from across the region. The Academy provided structured technical training, peer exchange, and site-based learning focused on biochar production, applications, and climate relevance, supporting capacity building and regional ecosystem development.

4b (Code:) (Expenses \$ 45,833 including grants of \$) (Revenue \$ 57,755)

Study Tour - During FY24-25, IBI successfully delivered the Wales Biochar Study Tour, with participation from more than 30 attendees. The program included site visits, technical presentations, and peer exchange, offering hands-on exposure to biochar production systems, applications, and regional approaches to implementation.

4c (Code:) (Expenses \$ 44,391 including grants of \$) (Revenue \$ 12,357)

Other Programs - During FY2425, IBI advanced several additional strategic initiatives and special projects that did not fall under its core program categories but directly supported the organizations mission. These included the development and coordination of externally funded and partner-supported projects, such as early-stage work related to international biochar initiatives in Pakistan, as well as grant-supported research and program design activities linked to philanthropic partners, including work associated with the Bezos Earth Fund. These efforts focused on project scoping, partner coordination, technical review, and early implementation planning, laying the groundwork for future education, deployment, and capacity-building activities.

Conference/Events - Throughout FY2425, IBI participated in and contributed to multiple national and international conferences and convenings to support knowledge exchange and sector positioning. These included attendance and engagement at events such as the North American Biochar Conference and Climate Week NYC, as well as additional regional and partner-led events. Participation focused on strengthening partnerships, increasing visibility of biochar solutions, and supporting coordination across the global biochar community.

Online Courses - IBI continued to offer its two established online biochar courses throughout FY2425, providing ongoing access to foundational biochar education for a global audience. In addition, IBI delivered a live Virtual Graduate Lecture Series featuring expert-led sessions. Recordings of these sessions were made available to extend educational access beyond the live events and support continued learning.

Biochar Marketing Campaign - In FY2425, IBI completed the Biochar Perception Study, a research-based initiative designed to better understand how biochar is perceived both within and outside the sector. The results have supported internal strategy development, communications planning, and stakeholder engagement by providing data-driven insights into awareness gaps, messaging challenges, and opportunities for sector-wide outreach.
