WE ALSO PUBLISHED A NEW INSTALLMENT IN 2023 OF TRANSPORTATION ELECTRIFICATION IN THE SOUTHEAST IN PARTNERSHIP WITH ATLAS PUBLIC POLICY TO TRACK AND CONTEXTUALIZE THE SOUTHEASTS EV MARKET AND EXAMINE SIX KEY INDICATORS ACROSS THE REGION. OUR ANNUALLY-PUBLISHED REPORTS TRACK MARKET, UTILITY, AND PUBLIC POLICY TRENDS ACROSS THE REGION IMPACTING THE ADVANCEMENT (OR STALLS IN PROGRESS, WHEN APPROPRIATE) OF CLEAN ENERGY. THROUGH THESE ANNUAL REPORTS, SACE RANKS THE PERFORMANCE OF OUR REGION'S UTILITIES IN COMPARISON WITH THEIR REGIONAL AND NATIONAL PEERS. WHILE WE DO NOT KNOW DETAILS OF ENERGY EFFICIENCY ASSUMPTIONS, TVA HAS AGAIN USED THE EE AS A RESOURCE METHOD TO EVALUATE ENERGY EFFICIENCY IN THIS UPCOMING IRP. THIS SUCCESS WOULD NOT HAVE BEEN ACHIEVED IF IT WERE NOT FOR MANY YEARS OF ADVOCACY FROM SACE.
