THESE ANNUALLY- PUBLISHED REPORTS TRACK MARKET, UTILITY, AND PUBLIC POLICY TRENDS ACROSS THE REGION IMPACTING THE ADVANCEMENT (OR STALLS IN PROGRESS, WHEN APPROPRIATE) OF CLEAN ENERGY.
