THE COALITION COORDINATED LOUISVILLE'S CONTINUUM OF CARE APPLICATION, RESULTING IN OVER 12 MILLION FOR HOMELESS SERVICES.

TARC TICKETS AND PASSES ARE THEN SOLD TO AGENCY MEMBERS AND PARTICIPANTS AT RATES APPROVED BY TARC. THE COALITION PURCHASES APPROXIMATELY 15,000 TICKETS AND 1,200 PASSES PER MONTH.

WHITE FLAG - THE WHITE FLAG PROGRAM PROVIDES EMERGENCY SHELTER FOR PERSONS WHO WOULD OTHERWISE BE TURNED AWAY DURING SEVERE WEATHER (ABOVE 95 DEGREES OR BELOW 35 DEGREES). THREE SHELTERS PARTICIPATE IN THE PROGRAM AND SUBMIT THEIR HOUSING NUMBERS BEYOND THEIR NORMAL CAPACITY TO THE COALITION FOR REIMBURSEMENT. THE PROGRAM PAYS FOR APPROXIMATELY 6,500 BED STAYS PER YEAR AT A RATE OF 5 PER BED STAY.
