SUMMER YOUTH INTERNSHIP PROGRAM: THE SUMMER YOUTH INTERNSHIP PROGRAM (SYIP) IS ONE OF MIAMIDADE COUNTY PUBLIC SCHOOLS' MOST TRANSFORMATIVE WORKFORCE INITIATIVES, OFFERING THOUSANDS OF HIGH SCHOOL STUDENTS PAID, FIVEWEEK, REALWORLD WORK EXPERIENCES THAT BUILD PROFESSIONAL SKILLS, EXPAND CAREER PATHWAYS, AND STRENGTHEN THE LOCAL TALENT PIPELINE. IN 2025, MORE THAN 3,600 STUDENTS ENROLLED AND COMPLETED THE PROGRAM. INTERNS GAINED EXPERIENCE ACROSS HIGH-DEMAND INDUSTRIES SUCH AS HEALTHCARE, TECHNOLOGY, EDUCATION, AND PUBLIC SERVICE, BUILDING CAREER SKILLS THAT ALIGN WITH THE EVOLVING NEEDS OF THE REGIONAL ECONOMY. THE PROGRAM ALSO SUPPORTED GRADUATING SENIORS BY ELIMINATING FINANCIAL BARRIERS TO KEY MILESTONE EVENTS A CAP AND GOWN FOR GRADUATION AND TICKETS TO PROM. MARKETPLACE PANTRY: THE M-DCPS MARKETPLACE IS A DEDICATED SCHOOL SITE PANTRY DESIGNED TO SUPPORT STUDENTS, FAMILIES, AND FACULTY IN NEED. THE PROJECT SERVES AS A CRITICAL RESOURCE FOR STUDENTS AND FAMILIES ACROSS MIAMI-DADE COUNTY, ADDRESSING THE URGENT NEEDS OF THOSE FACING HOMELESSNESS, FOOD INSECURITY, AND UNEXPECTED HARDSHIPS. THE PRIMARY BENEFICIARIES OF THE MARKETPLACE ARE STUDENTS, PARENTS, AND FACULTY MEMBERS REFERRED BY SCHOOL STAFF. SECONDARY BENEFICIARIES OF THE PROJECT ARE OUTSIDE COMMUNITY MEMBERS. AS OF MARCH 2025, THE MARKETPLACE PROGRAM HAD SERVED 14,150 STUDENTS AND FAMILIES AND DISTRIBUTED 383,900 POUNDS OF FOOD. STEAM/STEM LABS: STE(A)M LABS ARE AN EDUCATIONAL SPACE DESIGNED TO INTEGRATE SCIENCE, TECHNOLOGY, ENGINEERING, ARTS, AND MATHEMATICS. IN MIAMI-DADE COUNTY PUBLIC SCHOOLS, STE(A)M LABS GIVE EVERY CHILD THE OPPORTUNITY TO PARTICIPATE IN HANDS-ON ACTIVITIES THAT WILL PROVIDE THE EXPERIENCE NEEDED TO SUCCEED IN OUR EVER-INCREASING COMPETITIVE HIGH-TECH WORLD.
